Document Checklist

As part of the Hotel Sustainability Basics Application form on the Green Key landing page, you will be asked to hand in a number of documents together with your application. The exact documents to be handed in will depend on the combination of mandatory and guideline criteria you choose to prioritise in the first and second year of verification. Please notice that a minimum of 8 modules must be completed for the first year; this can come from any combination within the 3 sections but must not exclude any of these 3 sections. Please find the detailed information about the number of mandatory and guideline criteria to be handed in for each category and the corresponding evidence that must be handed in, in the table below:

	E2. Measure and reduce water	Total water consumption, total water consumption per occupied room in the reporting period, and total water consumption for each month/quarter in the reporting period (m3). This info must be uploaded using the Data template	
		Water bills/documentation of water consumption for each month/quarter during the reporting period. Please provide us with the bills in both original language and English.	
		Water Reduction Plan / minimum of 3 water reduction actions The actions must be reported in the <u>Action template</u>

	E3. Measure and reduce carbon emissions	Hotel Carbon Measurement Initiative (<u>HCMI</u>) result. This info must be also added to the <mark>Data template</mark>	
	E4. Identify and reduce waste	Information about the three biggest types of waste in your establishment including photos of the bins/containers showing these types of waste.

Green Cleaning Products	A list of daily cleaning products with the indication of which products are eco-labelled (including the name of the eco-label), plus the percentage of daily cleaning products that have an eco-label relative to the total of daily cleaning products. 		Purchase orders/invoice/contract for the purchased eco-labelled products. Please provide the documents in both original and English language.	
	PL3. Vegetarian Options	An overview of the various Food & Beverage outlets (restaurants, cafés, etc.) and the type of services (breakfast, lunch, dinner) in the establishment. <i>Please provide the overview in both original and English</i> <i>language</i> .	
		Documentation (photo/PDF) for each menu/buffet with an indication <u>for the guests</u> of the vegetarian choice for each course.	
		For establishments without Food & Beverage outlet, documentation (photo/PDF) about the type of information given to guests about the nearest restaurant with vegetarian options on the menu.

No Single- Use-Plastic Straws and Stirrers	The percentage of reusable straws/stirrers used in the establishment, and invoices/proof of purchase/contract of sustainable straws and stirrers (as alternative to single-use plastic ones). <i>Please provide the documents in both original and English</i> <i>language</i> .	
	PL5. Replace Single-Use Plastic Water Bottles	The percentage of reusable water bottles used in the establishment, and photo documentation showing that single-use plastic bottles are replaced with alternatives.	
	PL6. Replace Single-Use- Plastic Mini Toiletry Bottles	The percentage of bathrooms without mini toiletries, and photo documentation showing that mini toiletries are replaced with alternatives (one picture showing common area plus one picture showing guest rooms).

For re-applying properties, please additionally make sure to have the following documents prepared:

- Proof of compliance with the previous energy, water, waste, and corporate social sustainability actions.
- An indication of the increase (in %) in eco-labelled products.
- An indication of the increase of vegetarian/vegan options offered.
- Documentation showing progress connected to the reduction of inequalities (*e.g.*, if the set targets from last year have been met) in the establishment and in the supply chain.
